Resolution Urging the Department of Education to Prepare Concrete Plans to Implement the Class Size Reduction Law Approved May 16, 2024

WHEREAS, the New York State Legislature passed Bill S9460/A10498 “Class Size Reduction” on June 1, 2022, and Governor Kathy Hochul signed the bill into law on September 8, 2022ⁱ amending §3 Subparagraph (ii)(A) of paragraph (b) of subdivision 2 of section 211-d of the New York State Education Law by adding: “The class size reduction plan shall prioritize schools serving populations with higher poverty levels”; and

WHEREAS, data provided to the Class Size Working Group by the DOE on September 8, 2023 shows that there are least twice as many schools in Districts 9 and 10 serving populations with higher poverty levels than the average of all other districts (See Appendix A-1); and

WHEREAS, the DOE’s initial Class Size Reduction Plan annual report was submitted to the New York State Education Commissioner on November 15, 2023, but has not taken measurable steps to implement class size reduction other than to compile classroom data and reportsⁱⁱ; and

WHEREAS, the Department of Education’s (DOE) Class Size Reduction Plan, signed September 29, 2023, ranks District 26 last out of thirty-two districts by level of compliance with the mandated class size capsⁱⁱⁱ; and

WHEREAS, the DOE and the School Construction Authority (SCA) proposed five-year capital plan for FY 2025-2029, dated February 2024, does not list any new capacity projects for District 26^{iv}; and

WHEREAS, the Class Size Working Group released its final report of recommendations on December 11, 2023^v; and

WHEREAS, majority members of the Class Size Working Group, including the Co-chair of the working group and Chief of Staff for Senator Robert Jackson, the Director of Class Size Matters, the Co-Executive Director of the Alliance for Quality Education, and others issued a press statement on December 11, 2023 urging the Chancellor to “implement their recommendations without delay”^{vi}; and

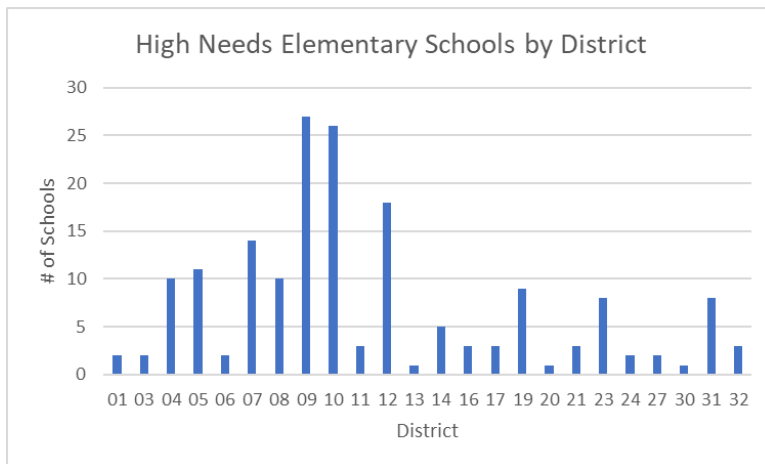
THEREFORE, BE IT RESOLVED, Community Education Council 26 demands the Department of Education to:

- Allocate sufficient funding in the capital plan to construct enough seats in District 26 to comply with the class size caps over the long term, e.g. – grades K-3 within 10 years; and
- Increase seat capacity in overcrowded District 26 high schools, e.g. – Francis Lewis, Cardozo, and Bayside; and
- Begin implementation of the Class Size Reduction Law in Districts 9 and 10, using all available policy levers and to include execution of the recommendations of the Class Size Working Group to the fullest

extent to achieve 100% compliance in grades K-3 in all schools within the two districts no later than September 2025. (See Appendix A-2)

During the CEC26 meeting held on May 16, 2024, the resolution was reviewed and unanimously approved by all members in attendance.
